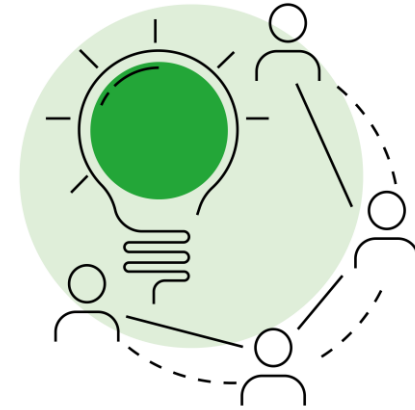

# Aims of LIAISON (5/2018 – 4/2022)

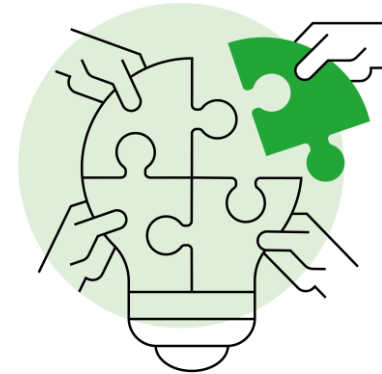
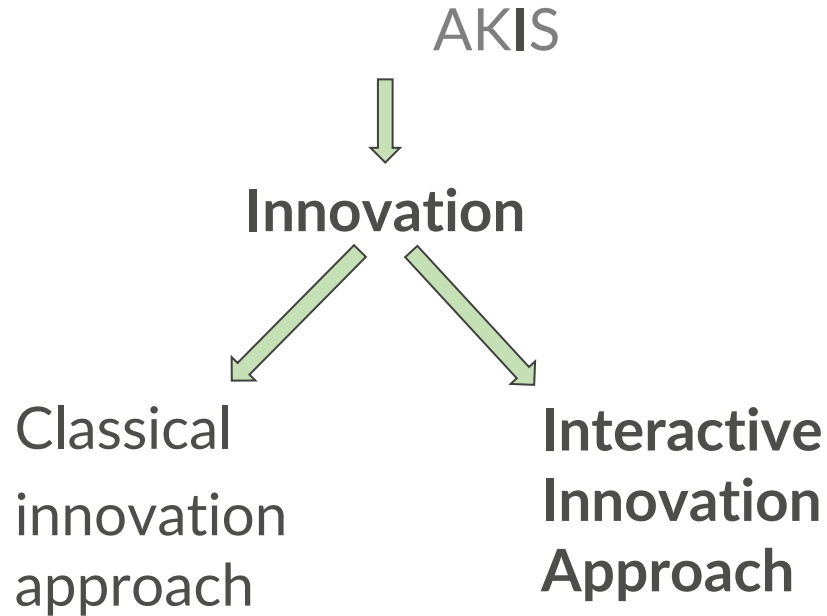
Why do some partnerships have the ability to organise themselves, to capture new ideas, to nurture them and create something new?

- Understand better what makes a successful partnership for innovation,
- Encourage more of these successful partnerships for innovation,
- **Develop recommendations to those providing the enabling environment for the implementation of such co-innovation projects.**

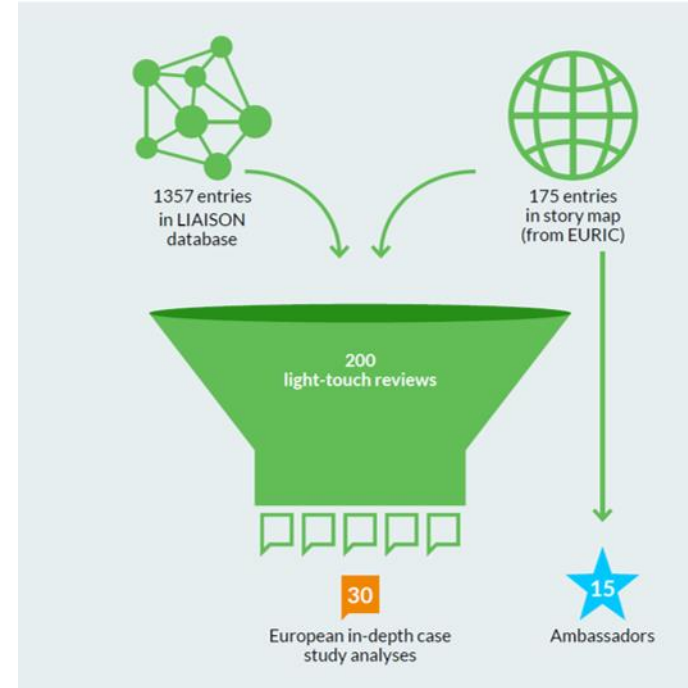


# LIAISON's evidence base

Light-touch reviews (200) and In-depth case studies (32): various types of multi-actor projects

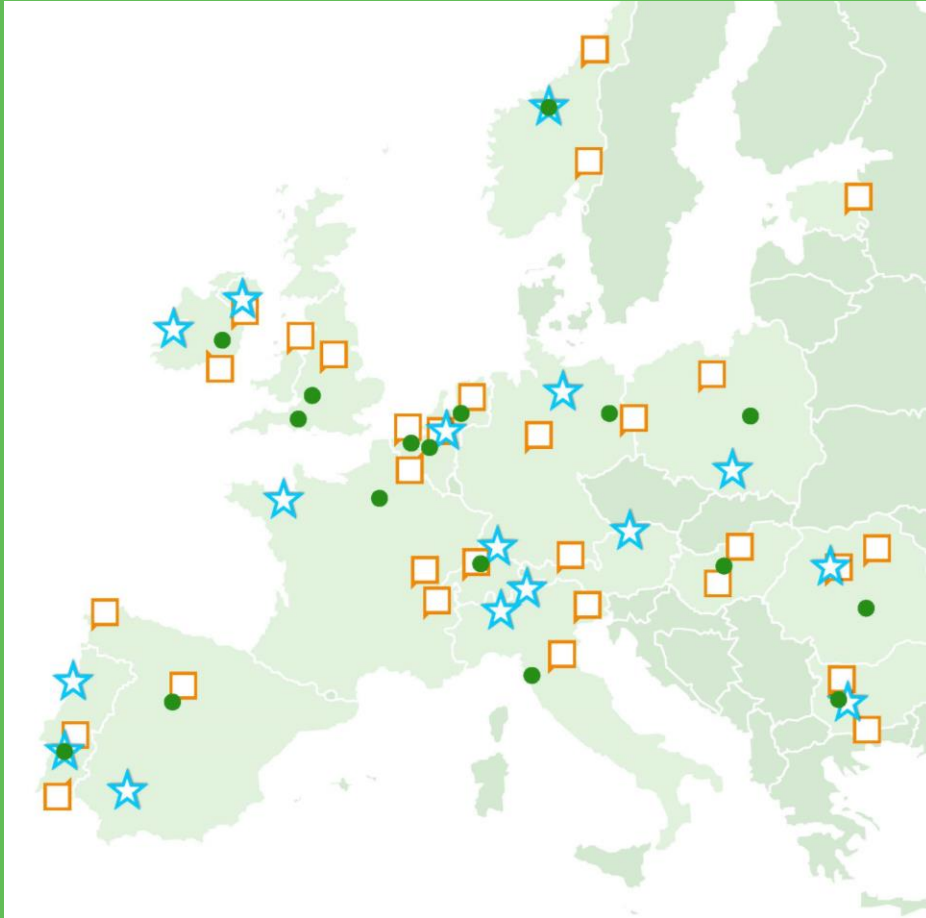
- Under the H2020/HEU programme (RIA, IA, CSA),

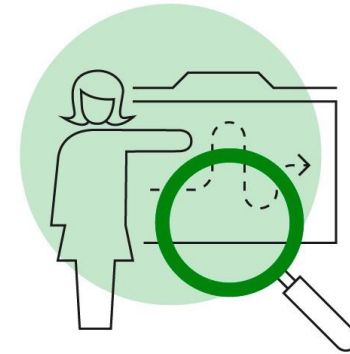

# „Roadmap to levelling up the EIP-AGRI - a Common Framework for functional Capacity Development in EU MS” (LIAISON Policy Brief2)

- It's evident, lots of progress has been made with the EIP-AGRI implementation since 2012.
- But we are realising that several improvements remain challenging.

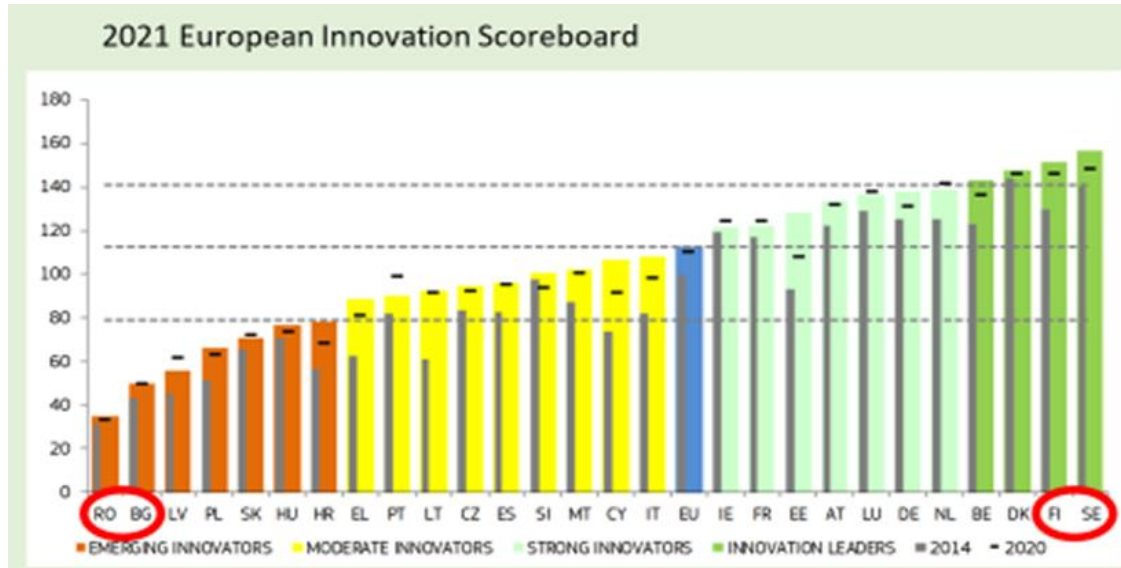
➔ LIAISON's insights from its field work and the work on the Common Framework on CD show that we need to **think bigger and keep an eye on the complexity of the EIP-AGRI implementation**, and the related **functional capacities** of all actors involved.





# Innovation gap in the EU

- The innovation performance of many MS is lagging significantly behind the 'innovation leaders'!
- With more support for the 'good' or 'medium performers', the risk of a further increasing 'innovation' gap grows!



# Varying innovation capacities in MS

- Political and institutional history, integration maturity, social and cultural context and level of decentralization differ substantially.
- Distinct and targeted CD intervention for individual MS are needed to speed up innovation.

➔ LIAISON teams recommend to develop Capacity Development as a core policy concept for implementation in the Post-2020 CAP.

# Five key Principles for optimising interactive innovation

## and the related capacities

- Capacity to **network** and collaborate (P1)
- Capacity to work with **diversity** (P2)
- Capacity to engage and act (P3)
- Capacity to **reflect, learn** and adapt (P4)
- Capacity to develop, translate and **implement responsive policies** based on need (P5)



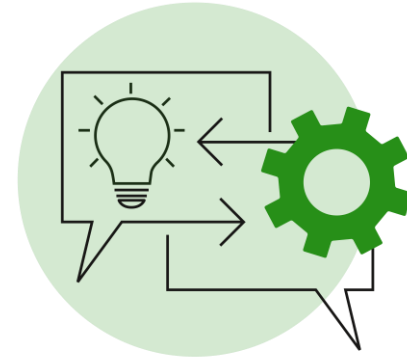
# World café results (11th meeting, April 2022)

- P1: Networking and effective collaboration is a key 'enabling capacity for innovation'; it requires teamwork and trust.
- P2: To tackle societal problems, actors needed are different, multi-level, and add multiple frames of reference, complementary knowledge, diverse range of policy options.
- P3: Co-innovation requires 'room for maneuvering' e.g. flexibility, taking risks, fail, learn, try again.
- P4: (Self-)reflection and reflexivity to improve structures and processes is central.
- P5: Fair and interconnected governance on multiple levels sets the frame for an enabling environment.



# CD support exists but ...?

- Which and where is CD support available?
- Who has access? How to know the support is provided? For whom? Transparency? Evaluation?
- How suitable is the use of CSAs for well-known CD needs? ... new CSAs will provide support for NCPs, ISS, AKIS or Advisory bodies ...but others?
- What is already out there and works for the CD for co-innovation? Towards Green Transition and other policy areas – maybe transfer to agriculture?
- What about their flexibility to MS' needs and contexts?

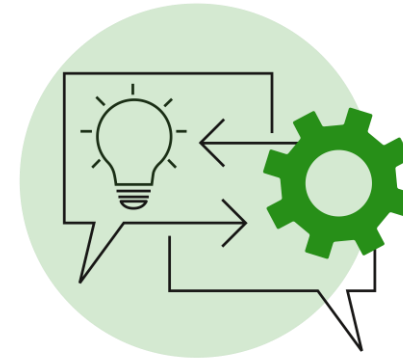
# “Strengthening the enabling environment for multi-actor process facilitation” (LIAISON Policy Brief 1)

- CAP Strategic Plans Regulation (SPR)
- Article 102 “Modernisation” -> Stronger AKIS!
  - Support farmers and their transition to more efficient and sustainable production systems
  - Connect ALL relevant AKIS actors systematically and intensively to create a well-functioning AKIS
  - Ensure co-innovation for new solutions and products, in particular co-design processes between practice and research



# Aim - Highlight opportunities for optimising the enabling environment for co-innovation

- Main focus is on the strengthening of the **innovation process management**.
- Policy programmes, administrative rules and procedures, including the tasks official innovation support services are commissioned to provide, shape the enabling environment.
- Target groups for this LIAISON Policy Brief:
  - Policy makers
  - Officials (agriculture, forestry, rural development)
  - Associated innovation support service providers, etc.

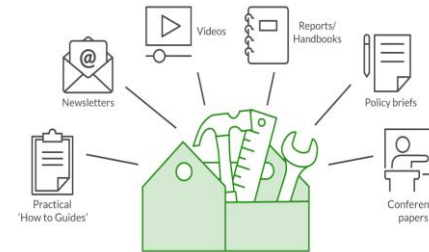

# Enhancing the enabling environment (1)

- Funding of independent support services that help
  - to shape an idea, to build a multi-actor partnership or the preparation of a project application
  - to find suitable partners (brokering)
- Appointing funding guides that point the way through the programme jungle
- Institutional funding for established networks
- Enriching education and training courses to build interpersonal, technical and functional skill needed for innovation process facilitation; and to teach more than only one professional



## Enhancing the enabling environment (2)

- Advising officials to engage as key AKIS players to help with e.g. stakeholder mapping, provision of knowledge and information, conference organisation
  - Funding for coordinators to sign up for 'classical' project management trainings
  - Funding for coordinators or dedicated partners to sign up for facilitation trainings, or for the contracting of external facilitators
- ! In most cases, providers of innovation support services working under a tender for the Ministry are not able to help with the project management and project-related facilitation tasks.
